#### 10. Any other business

- a) A discussion followed regarding a suitable Lent course. HO to research.
- b) Nigel Strudwick has offered to help with fund raising for the Fabric Fund by conducting a tour of Ely Cathedral. It was agreed that a talk in the Village Hall would be welcomed, and this could lead to a further tour of the Cathedral in person. All very grateful for his kindness.
- c) DG reminded the PCC of his talk on St Kilda in the Village Hall on 22 January 2025 at 7.30pm
- d) Asking for an additional charge for funeral and significant events during autumn and winter was discussed. It was agreed JG would add £50 to the invoices for these events unless the autumn was particularly warm and didn't require the heating to be put on. This was proposed by DG and seconded by KSC.

- e) HO reminded the meeting that her offer of a concert with her friend harpist Sophia was still a possibility. It was suggested a date in early summer would be good.
- f) HS talked through the various musical events planned for the forthcoming months.

i. Another 'Come and Sing Hallelujah' event on Saturday 12 April, open to everyone.

ii. The choir will sing at Holy Communion on Easter Sunday, 20 April.

iii. Reed Choir are inviting Whaddon Choir to join them in singing at a Choral Evensong at St Albans Abbey. They would also like to precede this with a practise run-through at Whaddon. The dates are as follows:

a. Choral Evensong at Whaddon on Sunday 18 May

b. Choral Evensong at St Albans on Friday 30 May Reed Choir

HS reminded everyone that Whitsun/Pentecost is on Sunday 8 June.

Sue Sentence has offered to be the Choir Secretary.

- g) HS asked about the prayer request box. KSC to ask Steve Coningsby if he can make one.
- h) KCL raised the requirements to collect the information required for a new Electoral Role as requested by the Ely Diocese.

She will publish the new form on 23 February 2025 to meet the time requirements before the APGM on Sunday 11 May 2025. Notices need to be given in church on Sunday 2 and 9 March. Members of the PCC offered to help distribute the forms as required to all parishioners.

## Parish Safeguarding Update for PCC Meeting on 14 January 2025

## 1. DBS Checks

#### 3. Whaddon Parish Dashboard

The Parish Dashboard has been upgraded significantly and I have started working through it, updating the review dates and working out a timeline of future deadlines. I will address the new requirements in stages over the next few meetings. The first is set out below – given we are such a small parish with almost no lone working, we can probably agree that we do comply, however it is worth noting the breadth of guidance that we would need to comply with should any lone working occur.

# • Is the PCC complying with the Church of England's safeguarding guidance regarding lone working with children or vulnerable adults?

This is to be reviewed at least once every two years./

'Lone working' from a safeguarding perspective includes:

- An adult being on their own with one or more children (under 18). This might occur before, during or after a church activity (e.g. giving lifts home).
- An adult being on their own with one or more vulnerable adults (e.g. during home visits).
- The online equivalent of the above situations (e.g. a one-to-one online chat or direct messaging).

The Church of England's safeguarding guidance regarding lone working are found in *Safer Environment and Activities*. Please especially see pages 8-9, 17, 18, 21, 23-24, 28 and 34.

Please note that the above guidance does not apply to someone who works on their own (e.g. a cleaner working alone in the church building). 'Lone working' from a **health and safety perspective** may still be of concern to the PCC, but it is not a safeguarding concern.

#### 4. Useful Information

I always include this section – it's useful to be reminded. The <u>Diocese of Ely</u> <u>Safeguarding page</u> is full of useful information including how to rep ort a safeguarding issue – briefly summarised below:

#### Reporting a safeguarding concern:

If you have information about a safeguarding situation where a child or adult is in immediate danger, or requires immediate medical attention, call the emergency services on 999. Do not delay.
